# **CAMARILLO & OXNARD AIRPORT AUTHORITY**

A. Subject: Selection of Chair and Vice-Chair for Calendar Year 2019

# Recommendation:

Nominate and select the 2019 Chairman and Vice-Chairman.

# Camarillo Airport Authority

Supervisor Kelly Long shared that the bylaws for the Camarillo Airport Authority need to be reviewed prior to the selection of chair and vice-chair. The chair position would normally go to the public member however the public member has reached their term limit under the current bylaws. It was determined that a special meeting to review the bylaws would be scheduled.

Public Member Bill Thomas moved to postpone the selection of the chair and vicechair for the Camarillo Airport Authority to next month's meeting in order for the bylaws to be reviewed. Councilmember Shawn Mulchay seconded the motion. All others voted in favor and the motion passed unanimously.

# Oxnard Airport Authority

A discussion took place as to whether the Oxnard Airport Authority would go forward with selection of chair and vice-chair. It was pointed out that there are discrepancies between the Oxnard Airport Authority bylaws and the Camarillo Airport Authority bylaws in the areas of term limits and compensation. Acting Director Jorge Rubio also shared that the bylaws

may need to be reviewed to confirm that they are consistent with the Joint Powers Agreement. Mr. Rubio also mentioned that the bylaws need to be reviewed to see if language should be added regarding conflicts of interest and the Fair Political Practices Act.

Public Member Walter Calhoun moved to postpone the selection of the chair and vice-chair for the Oxnard Airport Authority to next month's meeting in order for the bylaws to be reviewed. Supervisor John Zaragoza seconded the motion. All others voted in favor and the motion passed unanimously.

# **OXNARD AIRPORT AUTHORITY**

B. <u>Subject</u>: Approval of, and Authorization for the Director of Airports or His Designee to Execute, a Lease Amendment Agreement with SBA 2012 TC Assets, LLC, for the tower location of cellular equipment at the Oxnard Airport for a Renewal Period of Five Years, commencing January 1, 2021, with three optional Five-Year Extensions, with an Initial Monthly Rent of \$3,000

### Recommendation:

Staff requests that your Commission/Authority recommend that the Board of Supervisors:

Approve, and authorize the Director of Airports or his designee to execute, a lease amendment agreement with SBA 2012 TC Assets, LLC, (Attachment) to extend its lease at 2889 W. 5<sup>th</sup> Street, Oxnard Airport, Oxnard, for a period of five years, with three optional five-year extensions, with an initial monthly rent of \$3,000, commencing January 1, 2021, along with advance rental payment of \$15,000 paid upon lease amendment execution.

Lease Manager Madeline Herrle provided staff's report on this item and explained the terms of the lease amendment agreement. Ms. Herrle responded to general questions from the Authority and it was clarified that this lease did not go out to bid.

A member from the Aviation Advisory Commission reported that the Commission previously heard this item and unanimously recommended its approval.

Supervisor John Zaragoza moved to approve staff's recommendation and Public Member Walter Calhoun seconded the motion. All others voted in favor and the motion passed unanimously.

#### 7. DIRECTOR'S REPORT

Acting Director Jorge Rubio provided an update on the hangar leases. The Department of Airports and the County Executive Office have been meeting with VCHOTA and there is a follow-up meeting scheduled on January 22, 2019.

Mr. Rubio shared that in regards to the loss of Airports Director Todd McNamee, a Celebration of Life took place and his family was very appreciative of the event. Mr. Rubio also shared that the County Executive Office is conducting a nationwide recruitment to fill the director position and a candidate should be selected in the next one to two months.

Mr. Rubio introduced new maintenance supervisor, Byron Hamilton, and shared that operations supervisor, Nick Martino, is no longer with the department. Operations supervisor John Feldhans will be overseeing Camarillo and Oxnard airports.

Mr. Rubio shared that the Northeast Hangar Development at Camarillo Airport is in the final stages of the permitting process and a ground breaking ceremony should take place in March or April, 2019. Mr. Rubio also shared that the Orbic Helicopters lease is set to revert back to the county in February 2019 however the tenant has opted to continue to rent the facility which they are allowed to do for up to five years. He also shared that the senior center in Oxnard is set to move forward. Lastly, he shared that the department continues to receive interest in the vacant land west of the terminal at Oxnard Airport so the department is working with consultants to determine the best fit for the department.
