3. APPROVAL OF MINUTES – February 4, 2019 (Special Meeting) February 14, 2019 (Regular Meeting)

Camarillo Airport Authority: Public Member Bill Thomas moved to approve the February 4, 2019 special meeting minutes and Councilmember Shawn Mulchay seconded the motion. All others voted and the motion passed unanimously.

Camarillo Airport Authority: Public Member Bill Thomas moved to approve the February 14, 2019 regular meeting minutes and Councilmember Shawn Mulchay seconded the motion. All others voted and the motion passed unanimously.

Oxnard Airport Authority: Supervisor John Zaragoza moved to approve the February 4, 2019 special meeting minutes and Public Member Walter Calhoun seconded the motion. Mayor Tim Flynn abstained. All others voted and the motion passed unanimously.

Oxnard Airport Authority: Supervisor John Zaragoza moved to approve the February 14, 2019 regular meeting minutes and Public Member Walter Calhoun seconded the motion. Public Member Walter Calhoun abstained. All others voted and the motion passed unanimously.

4. PUBLIC COMMENT - Citizens wishing to speak to the Authorities on an airport related item must fill out a speaker card and submit it to the secretary. Comments will be limited to a maximum of **three** minutes per item.

Speaker cards for issues <u>NOT</u> on the agenda must be submitted <u>before</u> the end of the public comment period.

Speaker cards for issues listed on the agenda must be presented before the item is up for consideration. Speakers will be called <u>when the item is presented</u>.

A tenant of the airport stated his concerns about the hangar lease negotiation process and about modifying the Authority bylaws to take away public comment.

Scott Barer introduced himself as the new president of the Camarillo/Oxnard Hangar Owners and Tenants Association. He requested that this body not take action on anything pending until the new airport director is in place.

A member of the public stated his concerns about language in the proposed Authority bylaws and how it affects the jurisdiction of the Airport Authorities.

Harvey Paskowitz, a member of the Aviation Advisory Commission, informed Authority members that at the last Commission meeting a subcommittee was formed to review their bylaws and at some point the proposed changes to the bylaws would be shared with this body. He also shared that County Counsel provided a training on the Brown Act and Fair Political Reform Act.

5. NEW BUSINESS

CAMARILLO & OXNARD AIRPORT AUTHORITY

A. <u>Subject</u>: Training on the Brown Act, Fair Political Reform Act, and Robert's Rules of Order

Leroy Smith of County Counsel went over a PowerPoint presentation and provided training on the Brown Act, Fair Political Reform Act, and Robert's Rules of Order.

Camarillo Airport Authority: Councilmember Charlotte Craven moved to receive and file County Counsel's presentation on the Brown Act, Fair Political Reform Act, and Robert's Rules of Order and Councilmember Shawn Mulchay seconded the motion. All others voted in favor and the motion passed unanimously.

Oxnard Airport Authority: Councilmember Bert Perello moved to receive and file County Counsel's presentation on the Brown Act, Fair Political Reform Act, and Robert's Rules of Order and Public Member Walter Calhoun seconded the motion. All others voted in favor and the motion passed unanimously.

B. <u>Subject</u>: Receive and File Report from County Counsel Regarding the Feasibility of Creating an Appeal Process for Terminations of Month-to-Month Leases of Aircraft Storage Hangars

Recommendation:

Staff requests that your Authorities receive and file the report from County Counsel regarding the Feasibility of Creating an Appeal Process for terminations of Month-to-Month Leases of Aircraft Storage Hangars.

Leroy Smith of County Counsel stated it is County Counsel's opinion that it is not feasible to create an appeals process regarding termination of month-to-month leases. A discussion took place about whether it is appropriate to establish an appeals board or process to address terminations of leases. It was clarified that the Board of Supervisors would have to delegate the authority to terminate leases to another body as the authority currently resides with the director of airports. Some Authority members mentioned that this matter should be addressed again at a future meeting.

Camarillo Airport Authority: Supervisor John Zaragoza moved to approve staff's recommendation and Councilmember Charlotte Craven seconded the motion. All others voted in favor and the motion passed unanimously.

Oxnard Airport Authority: Councilmember Bert Perello moved to approve staff's recommendation and Supervisor John Zaragoza seconded the motion. All others voted in favor and the motion passed unanimously.

C. <u>Subject</u>: Review and Approve the Bylaws of the Camarillo Airport Authority and Oxnard Airport Authority

Recommendation:

Review and approve the bylaws of the Camarillo Airport Authority and Oxnard Airport Authority.

Acting Director Jorge Rubio shared that staff incorporated Authority members' comments/suggestions from the special meeting that took place on February 4, 2019 into the redlined version of the bylaws. It was clarified that the yellow comments in the redlined version outline the changes discussed at the special meeting.

The Camarillo Airport Authority reviewed staff's recommended changes to the bylaws. The following comments/suggestions to the bylaws were discussed:

The Oxnard Airport Authority reviewed staff's recommended changes to the bylaws. The consensus is that no changes are needed however Chair Walter Calhoun requested that approval of the Oxnard Airport Authority bylaws be agendized for the Authority's next regular meeting.
