

Discussion:

The purpose of this project is to replace and relocate the airport rotating beacon at Camarillo Airport. The existing beacon at the Airport is currently located on top of the water tower near the Airport campus and needs to be relocated to allow for easier maintenance and access. Due to the age of the existing beacon, replacement of a new beacon at a new location is the preferred option.

One addendum was issued during the bidding period which confirmed the height and tip-down requirements of the beacon tower. Bid opening was on October 3, 2023. A copy



of the bid abstract for the one bid received is attached (Exhibit 1). The bid has been reviewed and is considered to be in satisfactory form. The sole bid, in the amount of \$495,495, was submitted by Vellutini Corporation, dba Royal Electric. The bid is 260% over the Engineer's Estimate of \$190,055.

It is recommended all bids be rejected because the only bid received greatly exceeded the Engineer's estimate and the project budget. The Airport plans to consider redesigning or adjusting the project to lower costs prior to re-advertising for bids.

Subject: Receive and File Staff Report Regarding Annual Wings Over Camarillo Air Show and Future Military Jet Aircraft Demonstration Flights at Camarillo Airport

Recommendation:

Receive and file a staff report regarding the 2023 annual Wings Over Camarillo Air Show and the use of FA-18 military jet, and similar aircraft, during future air show demonstration performances at Camarillo Airport. The Department of Airports is working with Wings Over Camarillo (WOC) leadership to determine if current generation military fighter jets, i.e. FA-18, F-16, F-22, and F-35, should be included in future air show performances.

Fiscal/Mandates Impact:

This item is presented for information only and it does not require consideration by the Board of Supervisors at this time. There are no fiscal impacts associated with the recommended action.

Discussion:

The WOC Air Show has been held at the Camarillo Airport for more than 40 years. The Wings Over Camarillo is operated as a 501(c)(3) non-profit organization that has contributed more than \$650,000 to local non-profit entities over the last 13 years. It is important to note that the overall support for this annual event is extremely positive throughout the entire County of Ventura. Attendance at the two-day event is typically between 15,000 and 22,000 people, additionally, there are approximately 2,000 volunteers who provide support at the air show.

The WOC will enter into individual contracts with various private aircraft flight demonstration performers. In addition, the WOC typically applies to the various military branches to request attendance at the air show. Almost nine months in advance of the annual air show, the WOC air boss will submit requests for various military aircraft to provide both static display and perform flight demonstrations during the air show. The military branches frequently approve the use of aircraft for static displays, but rarely approve flight demonstration aircraft. The WOC full list of air show demonstration aircraft

performers will typically include World War II bombers/fighter aircraft, light aerobatic aircraft, aerobatic helicopter, light jet aircraft, and skydivers. However, the WOC was able to secure a current generation military fighter aircraft, the Boeing FA-18, to perform their flight demonstration routine during both the 2021 and 2023 air shows.

This current generation military fighter aircraft, although interesting to observe and the top attraction according to the surveys of patrons, has resulted in significant noise concerns from both our Camarillo Airport neighbors and the local animal shelter. During the 2023 air show the FA-18 first raised concerns with our neighbors on Thursday, August 17th during the aircraft arrival. This was followed on Friday, August 18th by two separate FA-18 orientation flights as both the primary and backup pilots needed to conduct familiarization and rehearsal in the Camarillo Airport airspace. Finally, on Saturday, August 19th the full air show demonstration performance took place. The air show was canceled on Sunday, August 20th due to weather concerns so no issues were raised.

The difference between the noise comments associated with the air show with and without the FA-18 aircraft in the performer's lineup were dramatic. For example, in 2022 when the WOC did not include the FA-18 aircraft performance the Department of Airports received approximately 15 noise complaints for the two-day event and no concerns were received from the local animal shelter. However, during this year's (2023) one-day event (due to Sunday's event being canceled) the Department received 124 noise complaints, with additional concerns being raised by the local animal shelter staff.

For the reasons listed above the Department of Airports is working with the WOC leadership to determine if future invitations, for similar military demonstration aircraft, will be offered to perform at the WOC air show event at Camarillo Airport. It is expected that this evaluation will require significant time and effort by all parties so it is not likely that the 2024 WOC air show will include this type of aircraft. Lastly, the WOC leadership has already reached out to the Point Mugu Naval Air Station command to determine if their facilities could be made available on a rotating basis to offer these popular current generation military fighter demonstrations to the public.

Subject: Receive and File Staff Update Regarding Security Upgrades at Camarillo and Oxnard Airports

Recommendation:

Receive and file a staff update regarding the modernization of access control, security cameras, and associated equipment currently being installed at Camarillo Airport and Oxnard Airport.

Fiscal/Mandates Impact:

This item is presented for information only and it does not require consideration by the Board of Supervisors at this time. There are no fiscal impacts associated with the recommended action.

Discussion:

Currently at both Camarillo and Oxnard Airports, access control to the airfield areas is provided by a combination of hardware components and cloud-based software that are connected via the internet to a vendor that provides database services through a license. The Department of Airports' (DOA) staff access the vendor's internet site to add or delete authorized users and groups, activate/deactivate gate entry cards, update credentials, and verify compliance with policies such as airfield driver training.

Originally designed and installed over 20 years ago, the hardware components consisted of motorized gates, card readers, cameras, data transmission radios, and associated cabling. Records from the time confirm that the legacy system's implementation was problematic due to the use of proprietary hardware and early generation network technologies. Various components were long-plagued with outages and over the years various components have been abandoned as obsolete. There are currently no working cameras from the legacy system and only the gate controllers remain active. Because the software is not owned by the County but rather accessed through a subscription, the annual licensing of the cloud database is a significant cost, and annual costs to maintain the aging hardware is also a factor and has become much less reliable over time.

In 2022 the County began working with Convergent, a specialist in security systems with extensive experience at airports, to design an updated system for both airports that would overlay and expand the legacy system functions, except utilizing modern technology with plug-and-play components. The gate locations, motors, card reader pedestals, enclosures, and power sources are being reused where possible. However, the addition of modern cameras, digital video recorders and the replacement of the wireless network backbone is the key to the modernization of the system.

In the time since the legacy system featuring proprietary technology was installed, advances in camera design, server capabilities, and networking technology now offer a huge leap forward in capability with the ability to swap out individual components as technology continues to advance. Thus, the new system offers the ability to feasibly replace cameras at all gate entrance locations and add many new cameras to enhance security visibility within the airfield areas.

The software portion of the system also offers new advantages. DOA will own the database software, called Genetec, rather than subscribe to a vendor's cloud software. The ability to manage the database onsite with dedicated servers connected through the County network enhances security, reliability, and reduces cost.

Implementation has not come without challenges, which DOA staff continues to work through. At Camarillo Airport, the original design envisioned having access to the water tower as an elevated platform and hub of the networked radios that connects the distant nodes to the server. Without the tower, additional radios will be located along the flight line requiring access to elevated positions and electrical power. Several locations on the west and north sides of the airfield still need to be connected to allow the system to feed network data back to the hub now relocated to the DOA Administration office. At least one of those locations had been planned for a mount on the west Sun Air hangar but complications in feeding power to the optimum point on the structure requires extensive electrical work and the final solution is still under consideration. Where new poles are needed to complete the network loop on the north side of the airport, airspace review of the final location/heights is required by FAA through Form 7460.

At Oxnard Airport, system implementation was delayed by the January 11, 2023, fire and the restoration work in the terminal building that prevented installation of cameras and the main server hub until August 2023. Additional network radios are also needed on the west side to reach the Victoria Avenue gate as well as on the east side near Ventura Road. DOA staff is working with the hangar association and the FAA to add radios and camera mounts at those respective locations and feed power to them. At least one pole location requires airspace evaluation once finalized. It is anticipated that one change order for each airport will procure the additional equipment needed to address the resulting design modifications.

Once all equipment is installed, there will be a phased changeover and commissioning period that will require individual gates to be briefly offline one at a time to switch systems. Training of DOA staff in the operation of the new system is expected to take place in the last two weeks in March after which it will be fully capable. The plan is for the system to be completely operational by March 31, 2024.

Residents cautiously optimistic about airport noise study


For many residents who attended the Ventura County Department of Airports' Sept. 26 workshop on the Camarillo Airport's noise compatibility study, frustration with noisy jets turned to cautious optimism about potential solutions.

The 20-month undertaking— in accordance with part 150 of Title 14 of the Code of Federal Regulations—began in January and will update two elements: the airport's noise exposure maps and its noise compatibility program.

Officials said the project will benefit residents by allowing airport administrators to better understand the extent of the noise and to determine strategies that reduce the impacts of the noise.

Attendees told the *Acorn* that the airport has been successful in informing the public and remaining receptive to feedback, and they are hopeful the study will make the noise more bearable.

“I think (the workshop) is a really good opportunity,” Camarillo resident Lauren De La Torre said. “I am hopeful this noise study is going to be the ticket to stop what’s happening right now.”



Residents of various Camarillo neighborhoods said the noise generated by airport traffic—primarily the jets—has become constant and unbearable. The sounds regularly wake them up late at night and early in the morning and make carrying on a conversation or watching TV momentarily impossible.

“It’s disheartening for somebody who’s lived in their house for 28 years to have to listen to this,” attendee Kristin Orosco said. “It’s never been this bad.”

Many track the tail numbers on the jets and have learned that most belong to celebrities who are probably not supporting local businesses.

“We’re just a parking lot,” De La Torre said. “And it’s hard to lose your quality of life because you’re giving someone who’s fairly well-to-do a place to park their jet.”

Attendees agreed that they are afraid the Camarillo Airport will become like other busier airports, such as the one in Van Nuys.

“I don’t think we can change it back, but we don’t want it to get worse,” Joe Schwander said. “You need a community effort to do this. One person or a few people coming out doesn’t do it.”

The first portion of the study updating the airport’s noise exposure maps is almost complete. Originally published in 1998, the maps identify current and projected aircraft noise levels at the airport and surrounding areas.

Over the summer, the department’s consulting firm collected noise data using measuring equipment and tracked flights’ dates, times, locations and types of operation.

The department also went beyond Federal Aviation Administration requirements by placing measuring equipment at the homes of residents who volunteered to be part of the study.

The firm is about to move to the second portion of the study, which updates the airport’s noise compatibility program. The program, adopted in 1999, identifies ways to reduce aircraft noise in residential areas, including changes in aircraft operations or facilities.

The project also encourages land uses that are compatible with aircraft noise, such as commercial or industrial uses in undeveloped areas.

The initiative does not serve as a justification for airport expansion.

“I’ll say it one more time: Amazon is not coming. We’re not extending the runway, and airline service is not coming,” Keith Freitas, county director of airports, said in an interview.

The Department of airports will host the third and final workshop early next year to collect community feedback, and a planning advisory committee composed of residents and other stakeholders will provide input.

“Participation helps us quantify what the issues are in the community and helps us help them,” Freitas said.

The final study will need to be approved by the Ventura County Board of Supervisors and the Federal Aviation Administration before it will be implemented.

Funded by a grant from the FAA, the project will cost roughly \$770,000.

Camarillo Based Pilot One of Many to Help Save Lives One Flight at a Time



Chances are that when most Ventura County residents think of Camarillo and Oxnard Airports, they think of current operations made up of mostly flight training, private jets, and businesses including Golden West Jet Center, Aspen Helicopters, Cloud Nine and the Waypoint Café just to name a few. Mixed in are likely memories of when Camarillo Airport was an Air Force base through the 1960s, or when Oxnard Airport's terminal was bustling with commercial travelers. There are likely even memories of the critical part Oxnard Airport played for the Army Air Corps and Navy during World War II.

What many arguably don't know is that the role of both airports extends well beyond traditional operations and into the realm of national non-profit organizations that focus on environmental conservation, life-changing flights to medical appointments, and animal rescue and sheltering – all made possible by locally based pilots who volunteer their time, fuel, and planes to conduct missions aimed at making a difference.

Among those pilots is Al Cossey, a Ventura County resident based at Camarillo Airport. Cossey is one of 348 active command pilots for the California-South Wing of Angel Flight West, a non-profit organization based out of Santa Monica Airport. Over the last 40 years, Angel Flight West has provided safe and accessible transportation to more than 20,000 individuals needing assistance to and from medical appointments and other destinations at no charge. The organization was originally established by volunteer pilots looking for a way to give back. Initially recognized as the American Medical Support Flight Team, the organization

merged with Angel Flight, a nationally based non-profit, and has completed 3,600 missions this year alone. This month, the organization will mark its 100,000th flight since its inception in the 1980s.

“There are 12 separate wings and of the 12 wings, the California-South Wing is the largest and most active,” Cossey said. “We might be based in Southern California, but we will fly anywhere that is needed.”

Made up of volunteer pilots, Angel Flight focuses its work on ambulatory patients with no other means of transportation to medical appointments, including surgeries, chemotherapy, burn care, and transplants. There are missions for children with severe burn scars headed to summer camps with other kids who have been through the same trauma. It’s a place they feel safe, Cossey said. And there are missions with urgent blood donations. The scope of work is nearly endless.

“It was developed to fill a need,” Cossey said. “All pilots are volunteers who believe wholeheartedly in the purpose of every mission. The original founders credited the decision to not reimburse volunteer pilots for expenses as a major contributor to assuring that those joining the organization did it for the right reason – to serve.”

Cossey added that missions were initially based on requests from hospital administrators or medical professionals, a requirement that has changed over time. Individual patients may now request their own flights, but medical documentation is still required to verify the need. Once scheduled, a volunteer known as a “Ground Angel” picks the client up from their home to take them to their destination airport. A volunteer “Command Pilot” then flies them to their requested airport where a second “Ground Angel” picks them up to take them to their appointment.

What happens when weather is a problem or pilots aren’t available? Angel Flight West has an established partnership with Alaskan and Southwest Airlines and tickets are available for those in need. Additionally, if a “Ground Angel” isn’t available, Angel Flight schedules and pays for ground transportation such as Uber or Lyft to and from the airport.

Cossey flies a handful of missions monthly in his Cessna 182 and noted that “Many pilots fly repeated missions with the same patients and get to know them well. There is an established rapport, and when we receive updates on clients, including those who have passed, well, it hits us hard and reminds us why we’re there.”

He continued, “You’re saving lives – human lives. And I can’t think of anything more meaningful than that.”

Fighter jets land at Camarillo Airport

Three combat jets developed for the Royal Air Force made an unexpected landing in Camarillo earlier this week.

Around 9:45 p.m. Oct. 24, the Hawker Hunters landed at Camarillo Airport after being diverted from Point Mugu, where their scheduled landing was canceled because of an emergency runway closure, said airport spokesperson Jannette Jauregui.

“We understand the concern this may have caused some members of the community and are aware of the noise associated with this type of landing,” Jauregui said in a statement.

The jets were able to leave Camarillo by noon the next day.

“We remain vigilant of the needs of our neighbors and are grateful for the continued partnership with nearby military bases as we collectively work to prioritize safety of all, especially in unplanned circumstances,” Jauregui said.

The aircraft, operated by Airborne Tactical Advantage Company and based at Mugu, are used for threat simulation, tactical air training and research and development.

The local Civil Air Patrol squadron will be on display on Nov. 7 to mark its 75th year of performing search and rescue in Ventura County.

The free event begins at 7 p.m. at 55 Durley Ave. at the Camarillo Airport and offers the public a behind-the-scenes look at the nonprofit auxiliary of the U.S Air Force.

Senior members and cadets will explain their roles in Squadron 61 before a Cessna 182 aircraft. Attendees can also jump into the cockpit of a flight simulator or view the air patrol's cache of specialized equipment.

The air patrol performs search and rescue efforts throughout Ventura County and the state and conducts aerial photography for the Federal Emergency Management Agency, Capt. Glen MacDonald said.

Squadron 61 is called out on search and rescue missions about five times a year, though most of those calls are the result of accidental activation of emergency beacons, he said.

The nonprofit also trains Air Force cadets and provides aerospace education to the public.
